APSN STRENGTHENS BOARD LEADERSHIP TO ADVANCE INCLUSION FOR THE SPECIAL NEEDS COMMUNITY

Singapore, 17 September 2025 – Following the Annual General Meeting (AGM) held on 16 September 2025, Mr Ng Mun Leng James has assumed the role of Chairman of APSN Ltd. He will steward the Board in discharging its fiduciary duties and upholding good governance as an Institution of Public Character (IPC). Under his leadership, APSN Ltd. will continue to strengthen and expand vocational training efforts at APSN Centre for Adults, with a focus on advancing employment training, job matching, reskilling, continuing education, and providing alumni support services for adults with mild intellectual disability aged 18 and above.

Mr Ng began volunteering with APSN in 2014 as a member of the Social Enterprise Sub-Committee and was appointed to the Board in 2016. He served as Vice-Chairman from 2020. Mr Ng has over 25 years of experience in senior management roles across marketing, corporate development, strategic planning, M&A, business development, and sales, primarily in the enterprise sector. Before joining APSN, he held leadership positions at EDB, NCS, ASE Investments, and ST Engineering, and worked in the USA and China.

“I am honoured to serve as Chairman and to build on the strong foundations laid by my predecessors. Together with the Board, we will strengthen training pathways and open more opportunities for adults with mild intellectual disability to thrive in society.” Said Mr James Ng, Chairman of APSN Ltd.

Mr Chan Kah Wai Julian and Dr Wei Ker-Chiah have been appointed as Vice-Chairmen of APSN Ltd. They will support Chairman Ng in discharging the Board’s duties and responsibilities.

Mr Julian Chan concurrently serves as the Chairman of the Digital and Technology Committee and Vice Chairman of the Nominating Committee. With over 25 years in regional IT leadership roles at global tech firms, he is passionate about leveraging technology to improve the lives of persons with special needs.

In addition to his role as Vice Chairman of APSN Ltd Board, Dr Wei Ker-Chiah will go on to serve as a member of the Nominating Committee. He began volunteering with APSN in 2017, contributing his professional expertise in psychiatry, and later served on the Programmes and Services Committee in 2022. Dr Wei currently chairs the Allied Professionals Advisory Panel and is a Senior Consultant and Head of the Adult Neurodevelopmental Service at the Institute of Mental Health.
